Order No-KIIDC/590/Micro Irrigation- Valiyeri LIS- Civil/2020 Dt. 03/09/2020

Vide Reference (1<sup>st</sup>) cited above, Administrative Sanction has been accorded by Government for five Micro Irrigation Projects for a total outlay of Rs- 20 Crore under Rebuild Kerala Initiative (RKI) Funds, and the execution of the projects is entrusted to KIIDC. The Outlay for Community Micro Irrigation in Valiyeri LIS in Kozhinjanpara Panchayath in Palakkad District is Rs- 3.88 Crore. The Micro Irrigation part of the Valiyeri LIS is proposed to be arranged with the condition that the implementing Agency will undertake operation and maintenance of the project for three years. The civil works involved will be arranged with usual tender conditions. Hence for the sake of convenience in arranging the works, the estimate is prepared for civil and micro irrigation parts separately. The estimate for the subject work is for civil and electrical works connected with Micro Irrigation Project in Valiyeri LIS.

Government have formulated a Technical Sanction Committee for the work vide ref (2) cited above. The Technical Sanction Committee met on 27/08/2020 and decided to issue Technical Sanction for the subject work. Accordingly the work named " Providing Community Micro Irrigation in Valiyeri LIS - ( Construction of Sump, Fertigation Room, Water Conveyance Pipe and Electrification for Micro Irrigation Work at Valiyeri LIS in Kozhinjanpara Panchayath in Palakkad District)" is hereby technically sanctioned for an estimate amount of Rs 49,90,000 (Rupees Forty Nine Lakh Ninety Thousand Only) including centage charges @ 6%, GST @ 12% on value of work and GST @ 18% on centage charges. The estimate is as per DSR 2016 with cost index 31.06% and registered as 25/TS/KIIDC/2020-21 dated 03/09/2020.
