As per Para No.169 of the Budget Speech 2017-18, an amount of ` 600 crore is set apart for the construction of 30 Regulators under Irrigation Department for funding under KIIFB.

As per Government Order read as 2nd paper above Managing Director, Kerala Irrigation Infrastructure Development Corporation Ltd. was nominated as Special Purpose Vehicle of Irrigation Department for undertaking all works proposed for funding under KIIFB.

The Chief Engineer (I&A), as per letters read as 3^{r d} paper above has submitted DPRs for the Construction of the following 5 works for an amount of ` 141,53,00,000 crore as detailed below for availing funding from KIIFB :


